ORDER

(UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE, 1973)

WHEREAS reports have been received that due to the situation prevailing in the areas under the control of Commissioner of Police Pimpri Chinchwad, it is noticed that use, sale and storage of Flying Lanterns during date 09/11/2023 to 15/11/2023 may cause danger to human life, safety and injury to public property on that account.

- 2. AND WHEREAS, it is necessary that some checks should be put on Flying Lantern related activities like it's use, sale and storage in the Pimpri Chinchwad Police Commissionerate, to prevent the activities of antisocial elements through such type of Flying Lanterns during the said period and that immediate action is necessary for the prevention of the same.
- 3. NOW THEREFORE, I, Vinoy Kumar Choubey, Commissioner of Police, Pimpri Chinchwad, vide powers conferred upon me U/sec 144 of the Criminal Procedure Code 1973(Act II of 1974), vide MSE-1274/ V-D&E dated 1st April 1974, do hereby order that the period of 07 Day's i.e. 09/11/2023 to 15/11/2023 no Flying Activities of such type Of Flying Lanterns and it's use, sale and storage (Éä not to allowed in the jurisdiction of Pimpri Chinchwad Police Commissionerate.
- This order shall remain in force with effect from 00.01 hrs. of 10/11/2023 till 24.00 hrs. of 15/11/2023 unless withdrawn earlier.
- Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code, 1860.
- 6. As the notice cannot be served individually to all concerned, the order is hereby passed ex-parte. It shall be published for the information of public, through press and by affixing copies on the Notice Board of the Police Stations, offices of the AC'sP, offices of the zonal DC'sP, Municipal Ward offices, and by affixing copies at Tahsil and ward offices.
